Entry Process:

The awards are open to all article writers who have been published up until December of each year AND who have not unsubscribed. These are for double page articles only.

The entry must represent an article that has been published.

Article writers can have multiple entries which includes all of the articles they have written and had published within the time period above across different categories.

Exclusions:

Articles including, a day in the life, travel articles or any other one-page interview based or theme based articles will not be included.

Article writers who have unsubscribed from the magazine will not be included in the nominee process.

Any special article writers who have NOT subscribed to the magazine will not be included e.g. charity articles, centre page spread interviews.

Sponsorship:

All sponsorship should be paid through bank transfer to Lydian Group Ltd.

Sponsors will not be in direct conflict with MO2VATE Magazine or any subsidiary company under the Lydian Group Ltd brand.

Each sponsor (if any) will be from a different industry ensuring there is no conflict of interest.

Sponsor fees are non-refundable under any circumstances.

Sponsors can also be article writers or subscribers for the magazine, or independent traders.

Sponsors will be required to provide a pre-recorded video to be played wishing the nominees good luck, introducing themselves and their business.

Payment:

There is no payment for these awards and they are fully complimentary by the magazine.

Entrants may remove their entry from the competition at any point.

Should an entrant wish to remove their entry, they must contact the organiser by email. Regardless if an entrant removes their entry.



If an entrant unsubscribes after receiving their nominee badge, they will be disqualified from the process and the nominee badge should be deleted.

Judging:

Winning entries will be those which, in the opinion and sole discretion of the panel of judges, best meet the judging criteria. We will have 3 independent judges within the judging panel to avoid bias. Any judge, with any personal interest or in any way related to a category will not be able to cast their judgement for that category.

Judging is conducted anonymously and impartially.

Judges will assess entries and Finalists will be announced during the week prior to the Awards Announcement date

The organisers are not held responsible for any emails, calls or other forms of correspondence that do not arrive for the International MO2VATE Magazine Awards for reasons outside the organisers control.

The judges' decisions shall be final and binding in all respects on all entrants. No correspondence will be entered into.

Editor's Choice

The Editors Choice articles will be voted for by the Editor in Chief.

Winners Announcement

The winners will be notified by email. The winners will be published on the MO2VATE Magazine website, the Awards brochure (post March Announcement) and social media platforms.

The winning entries will be collated for the website. If appropriate high-res images are not provided for this, the winner profile will be published without images.
